### Crawford County Sheriff's Office Press Release

*The following subjects have been charged with a crime but are presumed innocent until proven guilty:*

On March 27, 2025 approximately 21:35 Crawford County Deputies arrested Paul Albertson, age 38, of Willow Hill, IL for; Crawford County Warrant – Failure to Appear – (Violation of Conditions of Probations). Albertson was extradited from the Jasper County Sheriff's Office and transported back to our facility. Albertson was processed through the jail and remains in custody awaiting a detainment hearing.

On March 27, 2025 approximately 16:49 Crawford County Deputies responded to a single vehicle accident CR 1075E near CR 600N in Honey Creek Township. A male juvenile, age 16, of Robinson driving a 1994 Chevrolet 1500 owned by Angela Zapor. Deputy's narrative; [UNIT 1] was traveling north on CR 1075 E, negotiating the curve, and went off the shoulder and went into a skid. [UNIT 1] then crossed the road and entered the west ditch, sliding sideways before rolling onto its top. Over \$1,500 in damage was reported. United Lifecare Ambulance Service, Robinson Fire Department, and Crawford County Rescue were dispatched to the scene. Minor injuries were reported but was released at scene. Shook's Wrecker Service of Robinson towed the vehicle from the scene due to the damage.

On March 25, 2025 approximately 08:00 Crawford County Deputies responded to a car/deer accident CR 1100E @ CR 900N in Robinson Township. Melinda Dennis, age 48, of Oblong driving a 2015 Buick LaCross collided with a deer causing over \$1,500 in damage. No injuries were reported and the vehicle was able to be driven from the scene.

Deputy's narrative; [UNIT 1] was northbound on CR-1075E, .01 miles north of CR-800E when [UNIT 1] failed to navigate a curve and drove into the southbound lane. [UNIT 1] continued off of the roadway and struck a utility pole. [UNIT 1] rolled several times and landed upright while facing west. United Lifecare Ambulance Service and Robinson Fire Department was dispatched to the scene. [UNIT 1] was transported to the Crawford Memorial Hospital. Crouse Wrecker Service of Robinson towed the vehicle from the scene due to the damage. Utility pole owned by Frontier Communications of Flora, IL

On March 22, 2025 approximately 23:18 Crawford County Deputies arrested Timothy Hout, age 53, of Lawrenceville, IL for; Unlawful Possession of Methamphetamine and Driving While License Suspended, Unlawful Possession of Drug Paraphernalia, and cited for Expired Registration. Hout was transported to the county jail for processing and remained in custody awaiting a detainment hearing. Hout was later released due to the Pre-trial Fairness Act with a future court date. Following a traffic stop on CR 700N near IL Rt 1.

Gannon was transported to the county jail for processing and remained in custody awaiting a detainment hearing. Gannon was later released due to the Pre-trial Fairness Act with a future court date. [UNIT 1] driven by A male juvenile, age 17, of Palestine driving a 2012 Nissan Crew PK owned by a male juvenile. [UNIT 2] Driven by Ricky Edwards, age 70, of Meron, IN driving a 2018 Subaru Forester. Deputy's narrative; [UNIT 1] was stopped at the stop sign on CR-1150N and North Trimble Road. [UNIT 1] attempted to cross the intersection and pulled out in front of [UNIT 2] who was traveling North on Trimble Road and struck the rear passenger side of [UNIT 1]. United Life Care Ambulance Service, Robinson Fire Department, Crawford County Rescue and the Robinson Police were dispatched to the scene. [UNIT 1] suffered minor injuries but signed a refusal on scene. [UNIT 2] was towed by Shook's Wrecker Service.

On March 13, 2025 approximately 15:00 Crawford County Deputies responded to a two-vehicle accident S. Steele near W. Grand Prairie Streets in Palestine. [UNIT 1] driven by Judith White, age 58, of Palestine driving a 2011 Dodge Nitro backed in to [UNIT 2] driven by Elizabeth Brown, age 80, of Palestine driving a 2018 Ford Fiesta. Over \$1,500 in damage and no injuries were reported. Both vehicles were able to be driven from the scene.
