**CRAWFORD COUNTY PUBLIC SAFETY TAX
PROPOSITION**

Shall the County of Crawford be authorized to impose a public safety tax at the rate of 1% upon all persons engaged in the business of selling tangible personal property at retail in the County on gross receipts from the sales made in the course of their business to be used for direct and indirect expenses related to Public Safety.
